



GROUP REGISTRATION CONTRACT

- 1. The group registration process is valid for a minimum of 10 delegates.
- 2. In order to facilitate your group registration, please fill out this form and return by email to: reg_espid23@kenes.com
- 3. In order to benefit from the reduced group registration fees, payments must be paid **prior to the below deadlines**.
- Please send the <u>fina</u>l name list no later than 4 weeks prior to the congress. Please do not send preliminary name lists.
- 5. Name changes will be permitted free of charge until **2 weeks prior** to the congress (up to 15% of the participants names). After this date, any name change will be subject to 30 EUR charge per name.
- 6. **Onsite group registration pick-up** for groups leaders will be available upon request.
- 7. Payment is accepted by credit card or bank transfer. Credit card payment is subject to **additional 4% commission.**
- 8. <u>Cancellation policy:</u> Refund of registration fee will be as follows:

Note! Refunds for groups will be processed after the congress.

- Cancellations received until and including March 16, 2023– full refund.
- Cancellations received between March 17, 2023, until April 20, 2023 50% will be refunded.
- As of April 23, 2023– no refund will be made.

9. Conversion policy:

- Up to the 20 April 2023 you will be able to change your registration category at no charge. For example, if you registered to attend in person at Lisbon, you will be able to change your registration category to Virtual and receive a refund of the difference in fees.
